# Coming up in 2022

CHARTER FOR THE PROTECTION OF CHILDREN TURNS 20!

As you know, the Diocese of Manchester released a <u>Special Report</u> this month highlighting the many safe environment initiatives undertaken here in New Hampshire over the past twenty years. As we look forward to the upcoming year, we recognize that June will mark the 20th anniversary of the *Charter for the Protection of Children*. The Charter was a pledge by the U.S. bishops to provide compassionate response to victims of abuse and implement policies and training programs dedicated to preventing the sexual abuse of minors in the Church.

We have made many strides over the past 20 years, but please be assured that our work will continue. REMEMBER: about 1 in 7 chlidren is sexually abused in their lifetime. This is a horrible statistic, but we can help change it! Vigilance is key. We need to continue teaching adults about appropriate boundaries; the warning signs of abuse and how to report suspicions; conducting timely background checks on all employees and volunteers who work with minors; teaching children about in-person and online dangers; and adering to all of our policies.

Thank you for your dedication to our safe environment initiatives over these past 20 years. Your work makes a difference in children's lives!

FINGERPRINTING for school staff is currently being scheduled through the State of NH by calling (603) 223-3867. All employees of Catholic schools are required to be fingerprinted and it must be completed within 30 days of hire!

BOY SCOUT CHARTERS: If your parish sponsors a troop, be sure to get a copy of the Charter. Charters are typically updated in December of each year and list the names of all adult voluneers..
